

**Entry into the territory of Guadeloupe by sea**  
**Arrêté préfectoral n° 2021 - 045**

**Mask and preventiv actions**

Anyone on board a ship, whether for personal, professional or training use, is required to comply with so-called "barrier" hygiene measures, physical distancing measures and wear a protective mask. This obligation also applies in the public spaces of ferry terminals

**Entry requirement for pleasure and passenger vessels**

- **Entry in Guadeloupe by sea is forbidden**

except for the following sources

- **Martinique, Saint-Martin, Saint-Barthélemy** : for compelling reasons only

Provide at least 48 hours before arrival: a declaration of honor of the compelling reason + supporting documents + Covid test results (PCR) carried out less than 72 hours before arrival in Guadeloupe

- **Ports de l'UE et Guyane** : for compelling reasons only

Provide at least 48 hours before arrival a declaration on honor of the compelling reason + supporting documents + Covid test results (PCR) carried out less than 72 hours before the crossing + declaration on honor of absence of symptoms + isolation of 7 days upon arrival. A strict isolation period of 7 days must be respected upon arrival in Guadeloupe. This isolation can be observed on board the ship, whether at anchor or in navigation, provided that you do not disembark for the duration of the isolation.

**Disembarkation on the territory only authorized to:**

- French nationals
- EU nationals
- Schengen area nationals
- Holder of a valid residence permit

- **Other provenance** : Any derogatory request must be based on an emergency or security reason; it is sent to CROSS-AG at least 48 hours before arrival accompanied by the form annexed to the PA n ° 2021-045 + negative covid-19 screening test (PCR) carried out less than 72 hours before entering Guadeloupe + sworn statement of absence of symptoms + documents justifying the reason for emergency or safety.
